SAFETY POLICY

At the Chino Creek Wetlands and Educational Park (CCP/Park) we want your visit to be safe and enjoyable. This document includes important information that you should know before coming to the park. Please keep this information in mind to help you prepare for your trip.

Park Rules

1. No kicking, picking up, or throwing of any rocks, dirt or plant materials.
2. Stay behind park leaders at all times during the wetlands Park tour.
3. Stay on the designated paths for the duration of the tour.
4. Do not jump into or on any ponds, bridges or equipment in the Park.
5. Keep your voices low to not disturb the animals.
6. Please respect the Park and the wildlife that lives there.
7. No littering.

REPEATED DISREGARD OF ANY OF THESE RULES MAY RESULT IN IMMEDIATE TERMINATION OF THE TOUR.

Park Safety

If for any reason an Inland Empire Utilities Agency (IEUA) park facilitator believes it would be unsafe to continue the field trip, that facilitator can end the field trip at any time. Necessary steps will be taken if a facilitator feels the safety of the participants, chaperones or other facilitators are compromised for any of the following reasons:

- Non-compliant participants
 - This includes:
 - Failure to comply with Park safety rules and/or procedures
 - Mistreating the wetlands natural environment
 - Failure to listen to the facilitators instructions
- Endangerment to the Park staff, chaperones, or any participants
- Endangerment to Park wildlife
- Dangerous weather conditions
 - i.e.: High or low temperatures, high winds, rough terrain, etc...

Heat and Sun Exposure

During the warmer weather seasons, expect high temperatures, intense sunlight and low humidity. Drink plenty of water to avoid dehydration. Bring the water you will need to the park. Drinkable water is available at only one location.

For sun protection, wear loose fitting, light-colored clothing and hats are encouraged. Apply sunscreen to all exposed skin and bring mosquito repellent.

Wildlife

Keep wildlife wild. Any wild animal may be dangerous if approached. Always view wildlife from a distance. Never feed wildlife; it is unhealthy for animals and may lead them to become aggressive towards humans. It is exciting to see wildlife, but remember that the Park is their home and it is our responsibility to allow animals to live their lives undisturbed.

Treatment Plant Rules

1. No food or drink allowed during the tour.
2. No backpacks, purses or bags are allowed on the tour.
3. Stay behind facilitators at all times during the tour.
4. Stay on the designated paths at all times.
5. Do not jump or shake any equipment in the treatment plant.
6. Do not touch or push any buttons or levers.
7. No littering.

REPEATED DISREGARD OF ANY OF THESE RULES MAY RESULT IN IMMEDIATE TERMINATION OF THE TOUR.

Treatment Plant Safety

If for any reason an IEUA facilitator believes it would be unsafe to continue the tour, that facilitator can end the tour at any time. Necessary steps will be taken if a facilitator feels the safety of the participants, chaperones, or other facilitators are compromised for any of the following reasons:

- Non-compliant participants
 - This includes:
 - Failure to comply with the safety rules and/or procedures
 - Damaging or disrupting any equipment at the treatment plant
 - Failure to listen to the facilitators instructions
- Endangerment to the facilitator(s), chaperones or any other participants
- Endangerment to the treatment plant
- Dangerous weather conditions
 - i.e.: High or low temperatures, high winds, rough terrain, etc...

Heat and Sun Exposure

During the warmer weather seasons, expect high temperatures, intense sunlight and low humidity. Drink plenty of water prior to avoid dehydration.

For sun protection, wear loose fitting, light-colored clothing and hats are encouraged. Apply sunscreen to all exposed skin. Note: There is no shade during the treatment plant tour.

Post Tour Instructions:

It is important to remember that you will be visiting a wastewater treatment facility which contains various bacteria and waste. Make sure to wash your hands immediately following the tour. Note: The facility contains various bacteria and waste so refrain from touching your face or mouth during the tour.

If at any time you feel unwell during the tour, please notify the facilitator immediately.
