**IEUA Board President Jasmin A. Hall Installed as President of the
California Association of Sanitation Agencies**

INLAND EMPIRE, CA – During the 66th Annual Conference hosted by the California Association of Sanitation Agencies (CASA), Inland Empire Utilities Agency’s (IEUA/Agency) Board President, Jasmin A. Hall, was installed as CASA’s new President.

CASA represents over 100 public agencies that engage in the collection, treatment or disposal of wastewater, resource recovery or water recycling. CASA’s mission is to provide trusted information and advocacy on behalf of California clean water agencies, and to be a leader in sustainability and utilization of renewable resources.

She is the Agency’s representative to a number of organizations and serves as Chair of the Santa Ana Watershed Project Authority Commission, President of the Chino Basin Regional Financing Authority and Director of the Inland Empire Regional Composting Authority.
